MEMBER IN GOOD STANDING

Per the Temple Emanu-El Constitution, members who are more than 60 days in arrears and who have not made special financial arrangements are subject to not receiving their High Holy Day Tickets and resignation as determined by the Board of Trustees.

RELIGIOUS SCHOOL FEES:

In order to register for religious school, all prior commitments must be met. Please visit our website for registration. Scholarships or special payment plans are available based on need and will be addressed individually.

BAR/BAT MITZVAH:

In order for your child to become a Bar/Bat Mitzvah all fees must be paid and your dues commitment must be current.

HIGH HOLIDAY TICKETS:

In order to receive High Holy Days Tickets, congregants must be in good standing (see Member in Good Standing Section). Dues, assessments, religious school fees, building fund fees, Bar/Bat Mitzvah fees and other charges must be current. Dues and assessments can be paid on a monthly, quarterly or yearly basis. Dues and assessments are to be paid at the beginning of each period.

- Monthly = due on the twentieth (20) day of each month
- ➤ Quarterly = due on the twentieth (20) day of June, September, December, March
- > Yearly = due June 20th
